Protection of Personal Information

Information on the Alcofrein program

Who has to register for the program?

► You are required to enrol in the Alcofrein program if you have been convicted of a criminal offence for impaired driving **and if the result of the assessment required by the SAAQ is favourable.**

If the result of the assessment is unfavourable, you are not required to enrol in the Alcofrein program.

Program objectives

The goal of the Alcofrein program is to educate and rehabilitate people by reminding them of the legal, social and personal repercussions of impaired driving and the effects of alcohol on the human body. It also sets out to debunk myths about alcohol consumption.

The program provides participants with information about how alcohol, drugs and medication affect them and their ability to drive a road vehicle. It also provides information about the resources available in the community for individuals who have a substance use problem.

Description

The Alcofrein program lasts three hours and is held only in the evening.

Procedure

The fee in the amount of **\$150**, payable by **certified cheque, postal money order or bank money order** to the **Minister of Finance**, must be paid in full for your enrolment in the Alcofrein program.

Once we have received your enrolment form and the payment in full, we will inform you in writing of the day, time and place of the Alcofrein program you can follow.
