IMPORTANT: This form is for owners of seized vehicles who wish to recover their vehicle **before the end of a 30- or 90-day impoundment period**. A favourable decision by the Société de l'assurance automobile du Québec (SAAQ) could allow you to recover your vehicle before the end of the impoundment period, subject to payment of the impoundment and towing fees.

If one of the reasons for seizure indicated on the *Procès-verbal – Saisie de véhicule** concerns street racing or car surfing (Reason 60, 61 or 62) or illegal remunerated passenger transportation by automobile (Reason 51), do not complete this form. You must file a motion with the Court of Québec using the **Application for Release From Seizure** online form, available at lexius-gnjq.justice.gouv.qc.ca.

YOU OWN THE VEHICLE AND WERE DRIVING IT AT THE TIME OF SEIZURE

Vehicle seized for driving without a licence (Reason 10 (expired licence) on the *Procès-Verbal - Saisie de véhicule**)

Operating or having the care or control of a vehicle while impaired, refusing to obey an order given by a peace officer or excessive speeding (Reason 33, 34, 35, 36, 37 or 40 on the *Procès-verbal – Saisie de véhicule**). **Instead, you must fill out the Application for Review – Suspension of a Licence or the Right to Obtain One.**

Driving without a licence (Reason 10 (except for an expired licence); Reason 11, 12, 13 or 14 (failing to comply with licence conditions or restrictions) on the *Procès-verbal – Saisie de véhicule**). **You cannot apply to have your vehicle released from seizure.** You will only be able to recover your vehicle at the end of the impoundment period.

YOU OWN THE VEHICLE BUT WERE NOT DRIVING IT AT THE TIME OF SEIZURE

Vehicle seized for driving with a licence under penalty or driving without a licence (Reason 10, 11, 12, 13, 14, 20 or 21 on the *Procès-verbal – Saisie de véhicule**)
