IMPORTANT:

This form is for individuals whose driver's licence or the right to obtain one has been suspended for 30, 60 or 90 days for any of the reasons listed below.

A favourable decision by the Société de l'assurance automobile du Québec (SAAQ) could result in:

- the suspension of the licence or the right to obtain one being lifted;
- the vehicle being released from seizure and impoundment, if applicable.

The review of a decision regarding one of the reasons on the statement of suspension related to street racing or car surfing (Reason 30, 31, 32, 33 or 34), distracted driving (Reason 14) or illegal remunerated passenger transportation by automobile (Reason 22) must be filed before the Court of Québec, using the *Application to Lift Suspension of a Driver's Licence or the Right to Obtain One* online form, available at lexius-qnjq.justice.gouv.qc.ca.

To be accepted, your application for review must include all the required documents. The above-mentioned brochure provides a list of the documents you must file with your application.

The penalties and the conditions for obtaining a new licence that apply under the *Highway Safety Code* are separate from those that apply under the *Criminal Code*. The licence suspension imposed under the *Highway Safety Code* will remain in effect and you will still have to undergo an assessment regardless of any related criminal charges or convictions. The fact that you have not been charged or convicted therefore does not constitute grounds for review.

Presence of alcohol detected in a driver subject to the zero-alcohol rule (Reason 1 on the *Procès-verbal – Suspension de permis ou du droit d'en obtenir un**)

- a copy of the certificate from a qualified technician

Approved breathalyzer test revealed a blood alcohol concentration equal to or in excess of 160 mg of alcohol per 100 ml of blood (grounds for vehicle seizure and impoundment)¹, and therefore equal to or in excess of 80 mg of alcohol per 100 ml of blood (Reason 2 on the *Procès-verbal – Suspension de permis ou du droit d'en obtenir un**)

- Was not driving or did not have the care or control of the vehicle
- Blood alcohol concentration was below 160 mg of alcohol per 100 ml of blood

- The original of the *Procès-verbal – Suspension de permis ou du droit d'en obtenir un**
- a copy of the certificate from a qualified technician
- the original of the *Procès-verbal – Saisie de véhicule***

On completion of an evaluation, the evaluating officer had grounds to believe the driver's ability to operate a vehicle was impaired by cannabis or another drug, or by a combination of alcohol and cannabis or another drug (Reason 7 on the *Procès-verbal – Suspension de permis ou du droit d'en obtenir un**).

- Was not driving or did not have the care or control of the vehicle
- The ability to operate the vehicle was not impaired by cannabis or another drug, or by a combination of alcohol and cannabis or another drug

- The original of the *Procès-verbal – Suspension de permis ou du droit d'en obtenir un**
- a copy of the document provided by the evaluating officer
- the original of the *Procès-verbal – Saisie de véhicule*** where applicable

Refusal to comply with an order from a peace officer (Reason 3 on the *Procès-verbal – Suspension de permis ou du droit d'en obtenir un**)

- Was not driving or did not have the care or control of the vehicle
- Had a reasonable excuse for not complying with an order from a peace officer

- The original of the *Procès-verbal – Suspension de permis ou du droit d'en obtenir un**

- the original of the *Procès-verbal – Saisie de véhicule*** if there is one where applicable

Driving at a speed that constitutes excessive speeding (Reason 11, 12 or 13 on the *Procès-verbal – Suspension de permis ou du droit d'en obtenir un**: a 7-day licence suspension does not qualify for review)

- Was not driving at a speed that constitutes excessive speeding

1. If a driver provides sufficient evidence that their blood alcohol concentration was not equal to or in excess of 160 mg of alcohol per 100 ml of blood at the time of the offence, but rather only equal to or in excess of 80 mg per 100 ml of blood, the SAAQ may decide to lift the vehicle seizure and impoundment. In such a case, however, the suspension of the driver's licence or the right to obtain one remains in effect.
