

## Checklist for Converting a Heavy Vehicle into a Motor Home

Equipment	Present
<b>Galley</b>	
Refrigerator designed for motor home use <i>Standards CSA 1.4/ANSI Z21.19 Propane refrigerator</i>	
Stove/Cooking appliance (2) designed for motor home use <i>Standards CSA CAN1-1.1/CSA CAN1-1.16/ANSI Z21.57 Propane cooking appliance</i>	
Counter	
Sink connected to drinking water supply and wastewater systems	
Drinking water tank with a minimum capacity of 20 L per motor home occupant	
Material in contact with the drinking water does not present a risk of contamination	
Wastewater tank(s) with an equal or greater capacity than the drinking water tank	
Wastewater drain valves	
<b>Bathroom</b>	
Toilet designed for permanent installation in a motor home and connected to the vehicle's wastewater tank or Certified Cassette toilet  In either case, the toilet must be securely installed to prevent shifting while the vehicle is in motion.  <i>Standards CAN/CSA-B45 Sanitary appliances (toilet, shower, bathtub, sink and water tanks)</i>	
<b>Vehicle measuring longer than 7 m (23 ft)</b> Bathroom including a shower with a curtain or door and a pan measuring at least 5 cm (2 inches) deep  Shower walls made of waterproof material extending from the floor to at least 15 cm (6 inches) below the shower head  <i>Standard ANSI Z97.1 (certified safety glass) Shower-bath stall glass tempered glass</i>	
<b>Vehicle measuring longer than 7 m (23 ft)</b> Water heater <i>Standard CSA 4.1/ANSI Z21.10 Propane water heater</i>	

Equipment	Present
<b>Bedroom</b>	
Bed or hide-a-bed	
Access to 2 emergency exits located in opposite directions	
<b>General</b>	
Electrical system independent of the vehicle's motor	
Permanent propane and/or electrical power supply system (3-day autonomy)*	
Number of seats and seat belts greater than or equal to the number of places to sleep (maximum 9)	
Heating system independent of the vehicle's motor	
Smoke detector	
Carbon monoxide detector	
Extinguisher with a 5-B:C fire rating	
Minimum of 2 seats with seat belts	
Latches that keep the cupboards and drawers closed while the vehicle is in motion	
Seats (If seats have been added, they must meet the requirements in the chart under the heading "Seats for Passengers.")	
Weight certificate including weight per axle (date-time-VIN-values in kg)

- \*Appliances must be installed according to the manufacturer's instructions.
- \*The presence of all the items on this checklist does not guarantee that the converted vehicle will be approved.
