2. False

If you bring your vehicle to a stop for road signs, traffic signals or traffic obstructions, you are still considered to be driving. You are therefore not allowed to hold any electronic devices.

3. False

Drivers holding a cell phone in their hand, or in any other manner, are presumed to be using it. Simply handling this type of device while driving, regardless of use, is an offence, Reading or writing text messages and emails or browsing the Web is also prohibited while driving a vehicle.

4. 23 times more likely

A study conducted by a team from Virginia Tech in the United States has concluded that heavy vehicle drivers who text while driving are 23 times more likely to be involved in an accident.

Browsing the Web with a device that is not equipped with a telephone function is also prohibited under section 443.1 of the *Highway* Safety Code. The law applies to all portable electronic devices, including phones, digital tablets, media players (music, video, etc.), laptops and GPS devices.

7. True

Using a cell phone or another portable electronic device, or consulting a display screen without complying with the rules for its installation and use, or handling such devices in any way, while driving, automatically leads to:

- First offence: \$300 to \$600
- Repeat offence (within a two-year period): \$600 immediate licence suspension in the case of a repeat offence (within a two-year period):
- First repeat offence: 3 days
- Second repeat offence: 7 days
- Third repeat offence: 30 days
