

IMPORTANT: This form is for any person whose driver's licence or the right to obtain one was suspended for 30, 60 or 90 days for the reasons listed below.

A decision by the Société de l'assurance automobile du Québec (SAAQ) in your favour could allow:

- the suspension of the licence or the right to obtain one to be lifted;
- vehicle release from seizure and impoundment, if applicable.

For reasons indicated on the *Procès-verbal de suspension** regarding street racing or car surfing (reasons 30, 31, 32, 33 and 34) or the illegal operation of a taxi service (reason 22) a motion must be filed before the Court of Québec, using the **Application to Lift the Suspension of a Driver's Licence or the Right to Obtain One** form, available from the Ministère de la Justice.

In such a case, however, the suspension of the licence or the right to obtain one remains in effect.</p>
